## 1. Introduction

This Privacy Policy governs the manner in which IJ Tours Ltd, trading as IH Manchester, collects, uses, maintains, and discloses information from or about you when you use our products and services, enrol and attend a programme or use the websites and newsletter sites. (“Sites”). This Privacy Policy applies to the Site and all products and services offered by IH Manchester. IJ Tours is a UK based company, working with individuals not only from the UK but from countries outside the EEA. We aim to comply materially with applicable privacy laws and regulations in each of the countries in which we do business. IJ tours Ltd are a controller and processor of data.

Because protecting your privacy is important to us, IH Manchester has implemented this Privacy Policy, along with a number of additional notices specific to clients, staff and host families, so that you fully understand:

- What information is held by IH Manchester?
- How the information will be used.
- With whom the information will be shared (if anyone).
- How to opt out of e-mail updates.
- How to exercise your legal rights regarding your personally identifiable information (“PII”) (including how to update or correct inaccuracies).
- What safeguards are in place to protect your information?
- Other information about your privacy.

By using our Sites or any of the products or services offered by IH Manchester, you signify your acceptance of this Privacy Policy. If you do not agree to this Privacy Policy, please do not use our Sites, products or services. ## 2. What information is held by IH Manchester?

IH Manchester limits the collection of PII to that which is relevant for the intended business and legal purpose as described in Section 3 below and outlined in our policy notices. IH Manchester will not store, access, transmit, retain or otherwise use your PII in any way that is incompatible with the purposes for which it has been collected or stored as described in this Privacy Policy, unless you authorized such alternative use in writing.

### 2.1. Registration Information

If you are enrolling onto a programme at IH Manchester you will provide PII as requested in our booking form and outlined in our student data protection policy.

### 2.2. Online Surveys

IH Manchester values opinions and comments from students so we may conduct online surveys. These surveys are entirely optional for all students. Typically, the information is aggregated and used to make improvements to IH Manchester products and services and to develop appealing content, features and promotions for customers. Survey participants are anonymous unless otherwise stated in the survey.

### 2.3. IP Addresses

IH Manchester collects IP addresses to help diagnose problems with our servers and for system administration.

### 2.4. At School Collection

IH Manchester collects additional information on students on school registration and induction. This is normally for safety of our students and staff along with legal requirements in the UK. Please see privacy notice for students/staff/hosts for more information.

### 2.5. Server Logs

Like many other websites, our servers may automatically record information about your IP address, which ads you click on, the page that directed you to our Site, and the browser type used while accessing our Site. A server log stores the information collected so it can be analysed for the purposes set out in [Section 4](#) below.

### 2.6. Other Sources of Personal Information

You may provide information to us when you telephone us, in messages you send to us, for example, via the “contact us” section of our website, when you log on as a member or by interacting with any of our social media platforms, for instance by liking and sharing our posts on Facebook or Twitter. Please ensure you read the privacy policies in relation to your social media accounts as we cannot be held responsible for their uses of your PII.

### 2.7. Non-Personally Identifiable Information

We may also collect aggregated and anonymous information that does not identify an individual, such as the date and time a given device/browser visited the Site, the web browser used, and the visited page that directed the user to our Site. This Non-Personally Identifiable Information (“Non-PII”) is collected and analysed to determine how a user may have been directed to our Site, their interests in our products and services, and how to improve our Site. We may also collect information about user activities on the Sites and other websites for the purpose of generating advertisements according to assumed or stated user interests and preferences. This may result in our ads being displayed on participating websites based on a user’s browsing activity. This is achieved by allowing third party advertising companies to access things like cookies, IP addresses, and server logs. Some Non-PII may be combined with a user’s PII to further enhance that user’s experience while on the Site. In such a case, or in cases where any of the information above is deemed to be PII under the laws of the particular jurisdiction that information becomes PII and will be handled in accordance with this Privacy Policy.

### 2.8. Credit Card/Payment Information

You may provide IH Manchester with credit-card or payment information through our online booking or PayPal. This information is not retained by IH Manchester after a payment has been made.

### 3. PII – Your rights

#### 3.1. Requesting PII

As stated above, you have a right to access the personal data that we hold on you. To exercise this right, you should make a Subject Access Request. We will comply with the request without delay, and within one month unless, in accordance with legislation, we decide that an extension is required. Those who make a request will be kept fully informed of any decision to extend the time limit.

No charge will be made for complying with a request unless the request is manifestly unfounded, excessive or repetitive, or unless a request is made for duplicate copies to be provided to parties other than the employee making the request. In these circumstances, a reasonable charge may be applied.

Further information on making a subject access request is contained in our Subject Access Request.

#### 3.2. Updating PII

IH Manchester shall promptly correct or complete any PII found to be inaccurate or incomplete. Any unresolved differences as to accuracy or completeness shall be noted on your file. Requests to update, correct or augment PII can be made by contacting us at the [privacy@ihmanchester.com](mailto:privacy@ihmanchester.com)

#### 3.3. Blocking or requesting erasure of your PII

If you no longer want to use IH Manchester services, you can ask us to delete and/ or block your PII from being used again. Whether and the extent to which we can honour such requests will depend upon the nature of our relationship with you and may vary in accordance with applicable law. Requests to block your PII from being used again or to delete PII can be made by contacting us as set forth in Section 12 below. However, please note that we may need to retain certain information, for example for legal or administrative purposes, such as record keeping, maintenance of opt-out requirements, processing claims or detecting fraudulent activities. We will retain information in accordance with the provisions of Section 4.2 below.

#### 3.4. Special offers and promotions

As customers of IH Manchester we would like to provide you with updates about discounted availability, special offers, new services and products of ours which may be of interest to you and to provide you with details of third parties whose products, services and special offers you might also be interested in.

Depending on your location (reflecting applicable law), you may have been asked to indicate preferences regarding the receipt of such information from us, including consent as to the means by which you would like to such receive it.

Wherever you are located (and reflecting any preferences you may have expressed) you may receive such information by letter, e-mail, telephone or any other reasonable means of communication. If you do not want to receive these updates and to understand more about other unsubscribe options, you may contact us as set forth in Section 12 below.

## 4. How will the information be used?

### 4.1. Use of the information

We may use the information we collect from or about you in the following ways:

- To verify your credentials and/ or identity you
- To carry out our obligations to you.
- To allow you to complete bookings, be employee and make payments.
- To manage your time with us, service your requests and administer our relationship with you.
- To allow us to contact you including for customer service and to confirm requests, payment and other transactions with us.
- To provide you with assistance in the event you need our help via telephone, email or in person.
- To enable us to perform our legal and regulatory obligations as a responsible educational provider and employer.
- To personalise your experience and to allow us to deliver the type of service you require.
- To improve our Sites in order to better serve you.
- To allow us to provide you with better service in responding to your customer service requests.
- To administer a contest, promotion, survey or other site feature.
- For marketing purposes – for more information on this please see [Section 3.5](#).
- To quickly process your transactions and bookings.
- To ask for ratings and reviews of services or products.
- To follow up with you after correspondence (live chat, email or phone inquiries).
- To notify you of important information
- To develop promotions and product improvements.
- For our reasonable business purposes, such as data analysis, audits, fraud monitoring and prevention, developing new products, enhancing, improving or modifying our services, identifying usage trends, determining the effectiveness of our promotional campaigns and operating and expanding our business activities.
- As we believe to be necessary or appropriate: (a) under applicable law, including laws outside your country of residence; (b) to comply with legal process; (c) to respond to requests from various authorities including public and government authorities outside your country of residence; (d) to enforce our terms and conditions; (e) to protect our operations or those of any of our affiliates; (f) to protect our rights, privacy, safety or property, and/or that of our affiliates, you or others; or (g) to allow us to pursue available remedies or limit the damages that we may sustain.

### 4.2. Retention of your PII

We will retain your PII for as long as necessary in order to fulfill the purposes set forth in this Privacy Policy. We will retain and use this PII only as long as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements and then delete it.

Even if you request to close your account, keep in mind that deletion by third parties to whom the information had been provided may not be immediate and that the deleted information may persist in backup copies for a reasonable period of time (but will not be available to others).

Our retention periods are set out in our privacy notices for relevant subjects.

## 5. Who will the information be shared with, if anyone?

### 5.1. Agents

We may share some of your PII with your agent, with consent from you. This will be done in relation to providing you and the agent with the services booked with us and us fulfilling our contract with you.

### 5.2. Other Companies

IH Manchester does not share PII with any other companies unless it is in direct relationship with your employment, programme or interaction with us. Please see additional data protection policy for specific subjects.

### 5.3. Customs and Immigration Authorities

Please also be advised that we may need to give cross border control agencies access to customer data. Accordingly, any information held about you and your travel arrangements may be disclosed if required by law to the customs and immigration authorities of any country in your itinerary.

### 5.4. Other Third Parties

We do not sell customer names or other PPII to other third parties for their marketing purposes and have no intention of doing so in the future.

### 5.5. Authorities Permitted By Law

We may disclose your information to law enforcement and other governmental authorities insofar as it is required by law or is strictly necessary for the prevention, detection or prosecution of criminal acts and fraud. IH Manchester may also disclose information, if, in good faith, we believe that disclosure is necessary or advisable including, without limitation, to protect the rights or properties of IH Manchester or in order to identify, contact or bring legal action against someone who may be causing interference with our rights or business, whether intentionally or otherwise, or when anyone else could be harmed by such activities.

### 5.6. Corporate Transactions

We may disclose your information to a third party who acquires any part of IH Manchester itself, whether such acquisition is by way of merger, bankruptcy, consolidation or purchase of all or a substantial portion of IH Manchester's assets.

## 6. Cross-border Data Transfers

In connection with these transfers of PII, your PII may be subject to privacy laws that may not provide the same protection as your country of residence. For example, government entities in the United States and other countries may have certain rights to access your PII. IH Manchester limit any PII that is transferred outside of the EEA, however with consent may need to do so at times for purpose of contract and safety to students and customers.



## 7. Browser Data, Cookies and other Web Technologies

### 7.1. Cookies

Like many websites, our Sites uses automatic data collection tools, such as cookies, to improve your user experience. Cookies are elements of data sent to your browser which can then be stored on your computer. We use cookies to:

- Help remember and process the items in the shopping basket.
- Understand and save your preferences for future visits.
- Keep track of advertisements.
- Compile aggregate data about site traffic and site interactions in order to offer better site experiences and tools in the future. We may also use trusted third-party services that track this information on our behalf.

Although you may disable cookies in your browser and still access and use this Site, disabling cookies may prevent you from taking advantage of certain features on the Site.

### 7.2. Google Analytics

This Site uses Google Analytics (“GA”) to collect data activity. GA may be used for Display Advertising.

This Site and third-party vendors, including Google, use first-party cookies (such as the GA cookie) and third-party cookies (such as the DoubleClick cookie) together to inform, optimize, and serve ads based on someone’s past visits to our Site; report how ad impressions, other uses of ad services, and interactions with these ad impressions and ad services are related to visits to this Site.

#### 7.4. Choices regarding your information

These opt-out mechanisms rely on cookies to remember your choices with respect to advertising on websites. #### 8.1. Security Measures

IH Manchester will take reasonable measures to: (i) protect your PII from unauthorized access, disclosure, alteration or destruction, and (ii) keep PII accurate and up-to-date as appropriate. We also seek to require whom we share PII to exercise reasonable efforts to maintain the confidentiality of PII about you. For online transactions, we use reasonable technology to protect PII that you transmit to us via our Sites. Unfortunately, however, no security system or system of transmitting data over the Internet can be guaranteed to be entirely secure.

If we update this Privacy Policy, we will notify you by posting the revised Privacy Policy on the Sites, and for certain revisions that materially expand the ways in which we use or share the information previously collected from you either display an alert next to the Privacy Policy or otherwise on the Sites in advance of and/or concurrently with the changes taking effect, or directly communicate with you in advance of the changes. Your continued use of the Sites, our products and services after the changes have been made will constitute your acceptance of the changes. Please do make sure you read any such notice carefully.
